- Every 30 seconds a child is sold.
- Over 10 million children being trafficked globally today.
- \$150 billion dollar enterprise.
- Human trafficking is the fastest and second largest criminal enterprise in the world.
- The average age of a trafficked child is 12-13 years old.
- Children are trafficked for sex, organ harvesting, labor, beggars, marriage, etc
- Children are sold for sex anywhere from 10-20 times per day. 1 in every four children that are being abused live in their own households.
- Over 90% of porn is non-consensual, making porn a large supporter of this industry.
- Over 80% of child trafficking is familial such as a family member, a friend, a neighbor, teacher, etc
- 1 in 4 girls are victims of sexual abuse as a child.

Paul Hutchinson is the primary investor and Executive Producer of the film "Sound of Freedom" The story of the rescue of over 120 victims in Colombia from a child trafficking organization - one of the largest child rescues in history. Paul himself held a pivotal role in the rescue and, in the movie.

Paul founded **Child Liberation Foundation**, an organization actively involved in the fight against child trafficking. He's lead or played a key role in over 70 undercover rescue missions in 15 countries.

Hada Vanessa is a Colombian mother, philanthropist, anti-child sex traffic advocate, business woman, actress and producer. Along her husband, she is the Executive Director and Spokesman of **Child Liberation Foundation**. They travel to speak and strategize with key world-wide leaders different methods and approaches to combat trafficking and unite humanity together to heal the world.

Child sex trafficking is the act of recruiting, harboring, transporting, providing, or obtaining a child for the purpose of a commercial sex act, in which the child is induced to engage in prostitution, pornography, or other sexual activities for financial or other forms of compensation.

IMPLEMENTING & ENFORCING ANTI-CHILD TRAFFICKING LAWS

STRENGTHEN CRIMINAL LEGISLATION

Enforce greater and stricter laws specifically targeting child sex trafficking, including:

- Increased penalties for offenders such as castration or amputation of body part use for offenders selling or raping a child under the age of 12.
- Enforce national state ID registration for porn site visitors, with penalization of shut down if they fail to comply.
- Extensive investigation and prosecution, and victim support.

ENHANCE LAW ENFORCEMENT EFFORTS

Allocate robust government resources to strengthen law enforcement agencies' capacity to investigate, apprehend, and equitably prosecute traffickers and pedophiles.

PROVIDE SPECIALIZED TRAINING

Invest in specialized national mandatory training programs on human trafficking, education, prevention, online safety, for all professionals who may come into contact with potential victims :

- All school personnel, children and parents incorporating age-appropriate curriculums.
- All travel and tourism, customer service oriented public and local establishments.
- All government working law officials.
- Any and all institutions that work directly with children.
- Any and all hospitals and medical institutions.

RAISE AWARENESS, SECURITY MEASURES AND EDUCATION

Launch government national public campaign raising awareness and education of the high alert and the dangers of child sex trafficking, the signs to look for, and how to report suspicions through:

- Main television media and radio stations educating communities
- Bill-boards
- Public transportation stations
- Mandatory schools new letters
- Involve national influential respected figures to campaign

SUPPORT VICTIM IDENTIFICATION AND ASSISTANCE

Allocate resources for victim identification and comprehensive assistance to survivors:

- Educational and vocational opportunities for survivors to reintegrate into society
- Administer an intensive full circle healing programs for victims
- Provide funds for a robust team of vetted qualified professionals to work specialized children institutions specifically for child trafficked victims
- Provide specialized medical and psychological care for sexual abuse sufficient time for patients to fully heal
- Establishing specialized shelters and placement of permanent homes, adoptions, foster care facilities, for children
- Implement government legal aid available to affecter persons

FOSTER COLLABORATION WITH NGOS AND CIVIL SOCIETY

Actively engage and collaborate with non-governmental organizations (NGOs) and civil society groups that work in the field of anti-trafficking.

Team up with organizations with valuable expertise that can provide support services to victims that complement government efforts.

DEMAND REDUCTION

strategies to reduce the demand for child sex trafficking, such as targeting buyers and implementing awareness campaigns to discourage the purchase of sex with minors.
